Cherokee County Solid Waste Commission Secretary's Minutes of Thursday, July 16, 2020.

The regular monthly meeting of the Cherokee County Solid Waste Commission was held Thursday, July 16, 2020 commencing at 6:30 p.m. at the Separation Center. Commission members present were: Smith, Lundquist, Fiser, James, Pederson, Hanson, and Parrott.

Also present were Brent Kach, Manager, Tim Buelow with Barker Lemar, and John P. Loughlin, co-counsel.

The agenda was presented with a suggested amendment to add discussion of certificate of deposit renewal. Following discussion there was a motion to approve the agenda as amended and presented by Smith. Second by Pederson. Motion unanimously carried.

The minutes from the June meeting were presented and reviewed. Following discussion there was a motion to approve the minutes as presented by Ludquist. Seconded by Fiser. Motion unanimously carried.

The Financial Report was presented by the Manager as provided by Chris from Burkhardt and Dawson. No action was taken.

The accounts payable were presented and reviewed. Following discussion there was a motion to approve the accounts payable per attached check register totaling \$29,906.36 by James. Second by Lundquist. Motion unanimously carried.

The Engineers Report was presented next. The engineer advised that the master plan had been approved by the IDNR along with the plans for the development of the next cell, A6. No action was required.

The Manager's Report was presented next. There was a discussion regarding the purchase of a bulldozer per the attached three bids. Following discussion there was a motion to approve purchase of the Komatsu bulldozer net of trade for the amount of \$ 337,500.00, that being the low bid with trade by Hanson. Second by Smith. Role call vote all aye except for Parrott nay.

There was a discussion regarding annual purchase of propane currently at the rate of 0.88 cents per gallon for a total of \$3,960. Following discussion there was a motion to approve the purchase of propane as presented by Lundquist. Second by Fiser. Motion unanimously carried.

Next was a discussion regarding certificates of deposit. Commissioner Lundquist noted that two CDs at State Savings Bank totaling \$26,170.53 came due on July 14, 2020. Following discussion there was a motion to authorize commissioner Lindquist to renew the two CDs at State Savings Bank for a 15 month term at a rate of .75% by Smith. Second by Pederson. Motion unanimously carried.

Next was a discussion regarding a restricted CD for Closure / Post Closure coming due on July 29, 2020 in the current principle amount of \$137,944.95, also held at State Savings Bank. Following discussion there

was a motion to renew that CD also for a 15 month term at a rate of .75%, that being the best available rate, by Pederson. Second by Hanson. Motion unanimously carried.

There being no further business there was a motion to adjourn by James. Second by Pederson. Motion unanimously carried.
